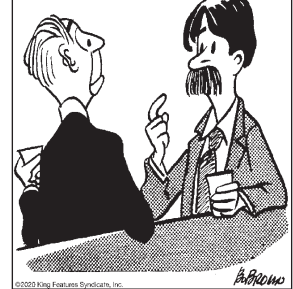

Section 17, T8N, R6E, located in Catahoula Parish, Louisiana. The legal description to the property is available at the Catahoula Parish Courthouse under the conveyance records.

This property is being sold as is. The government does reserve the right to cancel the sale at any time during the sale process and reserves the right to reject any bids on the property that is being listed for sale.

Sealed bids submitted on Form FSA-2592, "Invitation, Bid and Acceptance Sale of Real Property by the United States", will be received at the Farm Service Agency State Office, 3737 Government Street, Alexandria, LA 71302, until 10:00AM (CST) Wednesday, September 23, 2020, and then publicly opened at this same location. You must call (318) 473-7721 to make an appointment to drop off your sealed bid at this USDA location. The sealed bid opening will be held outdoors to adhere to COVID19 social distancing protocols. Persons wishing to attend the sealed bid shall wear a mask during the duration of the bid opening process. In the event of inclement weather, the sealed bid will be moved indoors at the same time and location. A ten percent (10%) deposit, in the form of a cashier's check, money order or certified check made payable to the Farm Service Agency must accompany each bid. Bids must be submitted in a sealed envelope that is marked "Sealed Bid Offer" with the property identification number on the outside of the envelope. The property identification number is 2201300040. Unsuccessful bidders will have their deposits returned within five (5) business days. Form FSA-2592 and instructions for submitting bids may be obtained from the Catahoula Parish FSA Office by emailing your request to john.bird@usda.gov or telephone the office at (318) 339-4239, Option #2, to setup an appointment to pick up the paperwork.
